



In Office Dental Savings Plan

The **In Office Dental Savings Plan** is a one year contract beginning the date the membership is paid in full. It is designed to help meet the dental needs of those patients with no dental insurance. It cannot be used by patients with dental insurance. This savings plan is not affiliated with any dental insurance plan or company.

How it works:

You simply pay a reasonable annual fee as an individual or a family and enjoy great savings and a way to budget your regular dental care needs.

The first member of the family pays \$325.00 to access \$565.00 value of benefits including:

- 1 Comprehensive Dental Exam and one periodic dental exam by the doctor
- Appropriate x-rays at initial and periodic exams
- 2 Healthy Cleaning Visits
- 2 Oral Cancer Screenings and 2 Fluoride Treatments
- 1 Emergency Exam and appropriate x-rays
- All dental treatment completed within the 12 months of enrollment will be discounted 15%*

Additional Family Members Living in the Same Household

Spouse/Significant Other/Child 14 to 21: \$270.00

Child under the age of 14: \$170.00

Benefits:

No annual maximum

No deductibles

No waiting period – this means you can start your treatment today

No preauthorization is required

Details

Premiums are yearly and benefits are in effect for one year from the date of paid enrollment.

Your annual plan benefits begin the moment your annual fee is paid in full. All benefits must be used within the premium year (there is no carry forward credit).

Initial Fee is nonrefundable.

An additional fee may be charged for any missed, cancelled, or broken appointment without 24 hours prior notice.

*To receive the 15% discount on other dental procedures in office, the total balance must be paid in full at the time of service, unless a written agreement is completed prior to treatment.

William A. Burn, III, DMD, PC reserves the right to refuse treatment and/or terminate the patient's participation in this Plan with 30 days written notice if the patient's account becomes delinquent or patient is non-compliant. This Plan may be modified, amended or cancelled at any time with 30 days written prior notice and may be subject to other terms and conditions. Plan participants are responsible for scheduling their periodic treatments, and services not used at the end of each year's membership period are not carried over to the following year. Discounts apply only to services performed by William A. Burn, III, DMD, PC, and does not include treatment or services provided elsewhere even if you are referred to a specialist.

Terms and Conditions, "The Fine Print"

This is a dental discount plan and NOT dental insurance.

It CANNOT be combined with any other dental insurance

It is good only at William A. Burn, III, DMD, PC. Therefore, if you are referred to a specialist, they will NOT offer this discount.

Should there be dental treatment needed following any type of injury where a lawsuit and therefore outside medical, auto or car, disability or workman's comp type insurances are involved, this discounted plan cannot be used.

This plan is Non-Refundable and Non-Transferable

Any "unused" benefits cannot be refunded, credited or carried over to the next annual period.

Plan is subject to change yearly.

All payments are due AT TIME OF SERVICE to receive the discount. Any services received that are not paid for at the time of service will be billed at the usual, higher fee.

If you choose to pay for treatment by using Care Credit or another health care financing firm, the restorative treatment discount is reduced to 5% due to merchant fees involved.

This offer cannot be combined with any other offers. Failure to comply with the terms of the Plan may result in termination of the Plan and forfeiture of any fee paid by patient or third-party.

Plan fees are valid only when paid at time of enrollment.

Offer valid for only 1 year from the time of enrollment.
